

PETITION FOR RECALL

TO THE HONORABLE Desert Sands Unified School District,

Pursuant to the California Constitution and California election laws, we the undersigned registered and qualified electors of the Desert Sands Unified School District, Trustee Area 3 of Riverside County, California, respectfully state that we seek the recall and removal of Tricia Pearce, holding the office of Governing Board Member, in Desert Sands Unified School District, California.

We demand an election of a successor to that office.

NOTICE OF INTENTION TO CIRCULATE RECALL PETITION. TO THE HONORABLE Tricia Pearce: Pursuant to Section 11020, California Elections Code, the undersigned registered qualified voters of the Desert Sands Unified School District, Trustee Area 3, in the State of California, hereby give notice that we are the proponents of a recall petition and that we intend to seek your recall and removal from the office of Governing Board Member, Desert Sands Unified School District, Trustee Area 3, in Riverside County, California, and to demand election of a successor in that office.

The grounds for the recall are as follows: 1. For failing to uphold her oath of office to protect and defend the Constitution of the United States and the Constitution of the State of California. 2. For abdicating her duties to her constituents to unelected bureaucrats in Sacramento. 3. For gaslighting her constituents about the curriculum of Ethnic Studies and the California State Seal of Engagement and approving said curriculum against the wishes of her constituents. 4.
